

# Network Capacity Building Grants - April 2018

Be Connected is an Australian government initiative committed to increasing the confidence, skills and online safety of older Australians. Be Connected aims to empower everyone to use the internet and everyday technology to thrive in our digital world.

Good Things Foundation are delighted to be leading the Be Connected Grants program. The Be Connected initiative includes a \$20m grant program which began in October 2017 and will finish in June 2020.

Over 1000 organisations have joined the Be Connected network since October 2017 to make change happen through digital for excluded people and communities. Becoming a Network Partner means that you are committed to improving the skills, confidence and online safety of older Australians.

As we prepare to move into Year 2 we are now inviting large scale community organisations to apply for a Network Capacity Building Grant, who:

- have the ability to recruit smaller organisations in their area into the Be Connected network
- or
- who already have an existing network in place over a wider area to target specific audiences (such as Indigenous people).
- or
- who are interested in developing and implementing innovative models for digital inclusion practice in their service type/community/state.

Capacity Builders will be ambassadors for Good Things Foundation and the Be Connected Network. They will work with Good Things Foundation supporting the program and acting as a 'critical friend' helping us to strengthen the offer for the Be Connected network and support Network Partners to meet the needs of older digitally excluded Australians. You will also support the development of digital inclusion practice across the country as you work with us to learn about what works in engaging and supporting older Australians to learn digital skills.

For Year 2 of the program (1 July 2018 - 30 June 2019), up to \$50,000 will be awarded to 20 organisations. The ultimate aim is for each new Capacity Builder to support up to 500 older Australians per year (250 in outer regional, remote or very remote locations) to access the [Be Connected Learner site](#).



In return, you will build a connection with a network of other Capacity Builders across the country that are passionate about ensuring that older Australians thrive in a digital world. You can test new approaches, learn what works in other areas, and help to build a community of best practice in digital inclusion.

## What do I have to do for the grant?

- The different types of activities that Network Capacity Builders will do are listed below. Please note, not every Capacity Building project will be the same, so not every Capacity Builder project will include each of these activities.

## Innovative service delivery

- Develop and use innovative models to deliver digital skills support at a local level that engage and support older Australians to develop their digital literacy skills and confidence.
- Develop innovative models to recruit other community organisations into the Be Connected network.

## Recruitment & Network Partner Support

- Identify community organisations to be part of the Be Connected network and promote the network offer (these can be all within the same organisation if there are a number of branches)
- Develop and deliver training (face-to-face and/or virtually) to network partners in the Be Connected network.
- Hold regular webinars/meetings with organisations and delivery partners to share stories, address barriers, learn lessons and celebrate success.
- Offer guidance and mentoring to other Network Partners.

## Be an ambassador of the Be Connected network

- Participate in network promotional activities e.g. speaking opportunities at local events and being prepared to talk about the Be Connected network at a local and national level.

## Working with Good Things Foundation

- Work closely with Good Things Foundation in an advisory capacity to support the development of the Be Connected program.
- Be prepared to participate in user testing and evaluation processes.

## Other requirements include:

A clear delivery plan to strategically identify the work you are going to do, quarterly milestones, and how you are going to adjust the plan based on feedback.

- Completion of a quarterly report on delivery plan progress.
- Completion of surveys or program feedback initiatives.
- Regular review of the learner data that's available on the Be Connected website.
- Provide a forecast budget at the start of the project
- Financial acquittals for the end of the financial year and the end of the project.

## What can the grant be used for?

The funding can be spent on activity that can be justified as supporting older Australians to gain basic digital skills and confidence. Examples include:

- Co-design or community consultation activities
- Conducting research and development or assessment activities to inform program delivery methods
- Piloting content or learning delivery models
- Travel to deliver program activities
- Staffing costs
- Project management costs
- Equipment and delivery costs

## Exclusions:

- Funding cannot be used for capital works (building or construction materials)

## Eligibility

Organisations who would like to apply for a Network Capacity Building grant must be a Network Partner within the Be Connected network. [If you are not yet a Network Partner, please click here to join.](#) You'll be able to apply for a Network Capacity Building grant as soon as you've completed the 'join the network' form, you don't need to wait for a call from us. We will be in touch within 2-3 weeks to support you with any questions you may have about being a new Partner.

For this funding opportunity you will need to provide an ABN number.

## Payments

Payments will be made in 2 equal stages:

- 50% in June 2018 to support with project set up and to start delivery
- 50% in December - this payment is subject to delivery against your project plan

- We have the potential and are willing to support seniors (aged 50+) to gain digital literacy skills.
- We will undertake police checks/working with vulnerable persons checks for all digital mentors. Please note, if you are successful you won't be able to accept the terms and conditions of the grant until you have current police checks in place.
- Our organisation has public liability insurance. Please note, if you are successful you won't be able to accept the terms and conditions of the grant until you have public liability insurance in place.
- We have fully accessible premises.
- We have an Australian Business Number - if you've not already supplied us with this information, you will need to input your Australian Business Number before you are able to apply.
