

# Digital Sisters Grant Program Guidelines

Research with settlement services indicates that digital exclusion is a key barrier for delivering support to new migrants and refugees.

Migrants and refugees generally have less access to devices, have limited local knowledge, face language barriers and rely heavily on informal community information systems.

Good Things Foundation Australia, in partnership with HOST International, will deliver a project to build and test a digital literacy program for refugee and migrant women aged 18 to 50 years that is culturally appropriate and builds capability in local people, support services and communities to deliver digital literacy support.

# About the program

Digital Sisters is a new digital inclusion program by Good Things Foundation for refugee and migrant women. The program aims to empower women to build digital skills, confidence and connections in the Australian community

Good Things Foundation and HOST International will work together with local communities, funded through the Digital Sisters Grant Program, to create and deliver a digital literacy program for refugee and migrant women.

#### **Grant Amount and Term**

We're looking for 20 community partners to help us create this program and deliver digital skills support to refugees and migrant women aged 18 to 50 years.

Participating organisations will receive \$20,000 grant funding, training and support to deliver the project from 1 August 2023 to 30 June 2024.

# Eligibility - Who can apply?

To deliver the project, your organisation must:

 Be a member of the Be Connected Network - If you are not yet a Network Partner, you can join using the <u>Joining the Network page</u> on our website. You can apply for the grant as soon as you submit the Join the Network form

- Already have contact with migrant and refugee women and be providing support to them
- Have an ABN

# What do I have to do for the grant?

Every funded organisation is required to:

- Participate in program co-design and resource testing activities
- Nominate at least 2 Digital Mentors to participate in 3 face-to-face digital mentor training sessions hosted by Good Things Foundation. It is preferred that the digital mentors are bilingual women already working in the community, where possible
- Participate in community of practice meetings online to discuss and share information, data, and good practice across all 20 funded organisations
- Participate in individual phone support calls from Good Things Foundation
- Deliver digital literacy programs to at least 40 refugee and migrant women in your community using the program framework, digital mentor training package and delivery resources, and service delivery principles as agreed in the co-design process
- Ensure all staff and mentors involved in delivering the Digital Sisters project have police checks
- Ensure learners attending a digital literacy skills session complete a sign-in form
- Ensure learner activity and data is gathered and reported on as agreed in the co-design process
- Host promotional events to inform the community of the availability of the program
- commit to supporting outcomes measurement and evaluation activities as agreed in the co-design process. This will include measuring outcomes for migrant and refugee women, Digital Mentors, and the Organisation
- Be prepared to share learner journeys and good news stories so that Good Things Foundation can create case studies
- Upon completion of delivery, submit a final report and financial acquittal

# Support you'll receive from us:

Funded organisations will receive support from Good Things Foundation including:

- \$20,000grant funding
- Professional development training for 2 Digital Mentors
- digital mentor training package and delivery resources
- Support to promote the project
- individual phone support calls

#### What can the funds be used for?

Funds can only be used for expenses directly related to the delivery of your project. You are required to clearly outline your proposed expenditure in the budget you submit with your application. The funds can be used for project-specific purposes, including;

:

- Communications, promotion and marketing expenses
- Police checks for all staff and involved in delivering the program, if not in place already
- Travel
- Staffing costs
- Project management costs
- Venue hire
- Equipment and delivery costs

#### **Exclusions:**

• Funding cannot be used for capital works (building or construction materials)

# **Notification and Payment**

All applicants will be notified of the outcome of their application via email by 28 July 2023.

If your application is successful, the full amount of the grant, \$20,000 (+ GST if applicable), will be transferred to you from 1st August 2023, once a contract has been accepted online and an invoice has been emailed to <a href="mailto:connect@goodthingsfoundation.org">connect@goodthingsfoundation.org</a>

# Reporting and Record Keeping

A final report is due within a month of the project's completion. The final report will detail what happened with the proposed project - successes, learnings, outcomes (a template will be provided by Good Things Foundation) and include a financial acquittal.

#### Retention of records

All grant recipients are required to keep original receipts or other documents, which account for the expenditure of the grant, for up to five years after the grant was awarded.

There is no need to hold off on your grant application before this phone call.
